DECLARATION OF SUNGATE TO BE AN APPROVED TOWNSHIP: TOWNSHIPS AND DIVISION OF LAND ORDINANCE, 1963

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I -

- (a) declare the area situated on Portion 55 of the Farm Ondekaremba No. 78, Registration Division "K", as represented by General Plan No. K447 to be an approved township; and
- (b) set forth in the Schedule the conditions subject to which the application for permission to establish the township concerned has been granted.

SCHEDULE

1. Name of township

The township shall be called Sungate.

2. Composition of township

The township comprises of 119 erven numbered 1 to 119 and streets as indicated on General Plan No. K447.

3. Reservation of erven

Erven 98 to 119 are reserved for the Estate Management Company for private open space purposes.

4. Conditions of title

The following conditions shall be registered in favour of the Estate Management Company against the title deeds of all erven except the erven mentioned in paragraph 3:

- "(a) The erf shall only be used for purposes, which are in accordance with, and the use and occupation of the erf is subject to, the provisions of the Kapps Farm Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance No. 18 of 1954).
- (b) The erven shall be subject to the development control measures and guidelines as prescribed in the precinct plans of the Urban Designer in the case when it is more specific than the provisions of the Kapps Farm Town Planning Scheme; and
- (c) The building value of the main building, including the outbuildings, to be erected on the erf shall be at least two times the municipal valuation of the property."
